



# Installation and Operation Instructions EW2000 SERIES LED WORKLAMPS

ECCO's EW2000 Series LED Pedestrian Spotlights are designed specifically for material handling applications to provide a visual warning for pedestrians in the vicinity of mobile equipment. These lights are intended as a supplemental safety device in addition to a 360° warning light and project a bright, 300 lumen spot beam (available in blue or red) onto the ground either in front or to the rear of the vehicle. This additional safety feature is especially useful where blind corners are present (i.e. warehouse racking) and is likely to be seen by pedestrians that are not looking up or paying close attention to their surroundings. Featuring 10-60 VDC operation, an aluminum housing and polycarbonate lens the EW2000 is extremely resistant to impact and vibration damage and has an IP67 ingress protection rating.

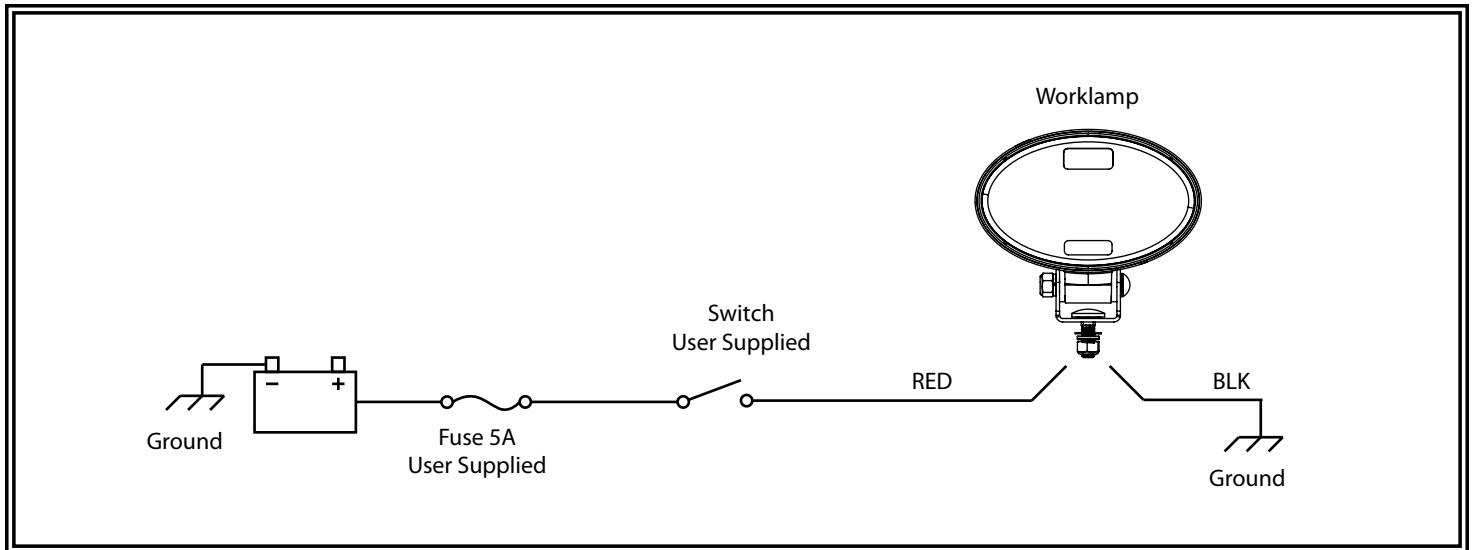
## **Installation:**

1. Select a mounting location for the unit on a flat surface. Drill a 0.332" diameter clearance hole in mounting surface (use a Q-sized drill bit). Place the unit and the 5/16" flat washer over the hole with the 5/16" carriage bolt through the washer and clearance hole and secure with a 5/16" lock washer and 5/16" lock nut on the bottom side.
2. Adjust beam location of the unit in the horizontal direction and tighten the 5/16" lock nut with a wrench.
3. Adjust the beam location of the unit in the vertical direction and tighten the 5/16" lock nut with a wrench.

## Wiring Instructions:

Black Wire: Ground  
Red Wire: Connect to fused power
